

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 2006 Title VI, Part C Program Budget Amendment 1)

RESOLUTION NO. 05-689

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the Elders of the**
2 **Nation; and**

3 **WHEREAS, funding for the operation of the TODHHS Division of Senior Services Division is**
4 **possible in part by Title VI of the Older American's Act of 1978 as amended; and**

5 **WHEREAS, on January 14, 2005 the Tohono O'odham Nation Legislative Council approved the**
6 **Title VI, Part C Program fiscal year 2006 budget of \$67,990.00 with Resolution**
7 **No. 05-046; and**

8 **WHEREAS, the Division of Senior Services has *modified* the approved budget to include the**
9 **salaries and fringe benefits for one new Caregiver Coordinator position utilizing part**
10 **of the funds that was budgeted for one Case Manager position; and**

11 **WHEREAS, the original budget has also been *amended* to decrease from \$67,990.00 to \$51,510.00**
12 **(Decrease of \$16,480.00) in accordance to the Grant Award letter received after the**
13 **approval of the \$67,990.00 budget.**


14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
15 **approves:**

- 16 **1. The fiscal year 2006 Division of Senior Services *modification/amendment* to**
17 **include the salaries and fringe benefits for one new Caregiver Coordinator**
18 **position utilizing part of the funds that was budgeted for one Case Manager**
19 **position; and**
- 20 **2. To decrease the budget from \$67,990.00 to \$51,510.00 (Decrease of \$16,480.00) in**
21 **accordance with the "Grant Award" letter received after the approval of the**
22 **\$67,990.00 budget for period April 1, 2005 to March 31, 2006.**
- 23 **3. The Tohono O'odham Nation officials, to wit: The Chairwoman is hereby**
24 **authorized to negotiate and execute the grant, provided however, that any**
25 **amendments affecting the funding or funding levels of this contract shall be**
26 **submitted for further prior approval by this Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH Day**
28 **of NOVEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
30 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
31 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
33 **Stat. 984).**


