

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving San Xavier Allottee Association (SXAA) Budget Modification #1 to use Carry Over SAWRSA Trust Funds to implement the Southern Arizona Water Rights Settlement Act of 2004)**

RESOLUTION NO. 05-691

- 1 WHEREAS, the Tohono O'odham Legislative Council approved funds to the San Xavier Allottees  
2 Association, Inc. from the SAWRSA Trust Fund in the amount of \$62,429 for the  
3 Allottee SAWRSA Project by Resolution 03-114; and
- 4 WHEREAS, the Tohono O'odham Legislative Council approved additional funding to the San  
5 Xavier Allottees Association, Inc. board from the SAWRSA Trust Fund in the amount  
6 of \$47,631 to fund an additional four months of the SAWRSA Allottee Project; and
- 7 WHEREAS, a balance in the amount of \$17,338.40 is left over from the original funding; and
- 8 WHEREAS, the Board of Directors of the San Xavier Allottees Association, Inc. has reviewed the  
9 proposed budget for 2005 - 2006; and
- 10 WHEREAS, the Public Hearing will be conducted at the Federal District Court on February 6, 2006  
11 to hear from the allottees how they understand what the affects of the proposed  
12 SAWRSA settlement is going to be; and
- 13 WHEREAS, the board members find that funding is needed to address the requirements of the  
14 Federal District Court's direction to hold four meetings reservation-wide with the  
15 allottees and inform them about SAWRSA and a Public Hearing that will be held on  
16 February 6, 2006.
- 17 NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council of the Tohono  
18 O'odham Nation continues to support the objectives of the original request for funds  
19 and approves the proposed budget of \$17,338.40 to be used by the San Xavier Allottees  
20 Association, Inc. to implement the Southern Arizona Water Rights Settlement Act of  
21 2004.

22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18<sup>TH</sup>. Day  
23 of NOVEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-  
24 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by  
25 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
26 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
27 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
28 Stat. 984).
