and the Matching Contribution of \$189,750.00)

RESOLUTION NO. 05-696

- 1 **WHEREAS, the Tohono O'odham Nation Police Department has successfully applied for and was**
2 **awarded a Community Oriented Policing Services -Tribal Resources Grant Program**
3 **Equipment Award (COPS-TRGP), grant funding through the U.S. Department of Justice**
4 **in the amount of \$569,250.00 under Grant Award Number 2005HEWX0076; and**
- 5 **WHEREAS, the grant is a two (2) year grant to be effective: August 1, 2005 thru July 31, 2007; and**
- 6 **WHEREAS, the grant requires a matching contribution of 25% which is \$189,750; and**
- 7 **WHEREAS, the matching contribution of \$189,750 has been identified under the BIA 638 Funds**
8 **when combined together for the total project cost of \$759,000; and**
- 9 **WHEREAS, these funds are free of any other match to other grants; and**
- 10 **WHEREAS, the grant waives the indirect cost which is deemed to be unallowable by U.S. DOJ Cops**
11 **Office; and**
- 12 **WHEREAS, the grant is to be used specifically for the acquisition of equipment needed by the**
13 **Tohono O'odham Nation Police Department; and**
- 14 **WHEREAS, the Tohono O'odham Nation Police Department is requesting the Tohono O'odham**
15 **Legislative Council for the approval, acceptance and authorization of this grant and**
16 **budget in the amount of \$569,250.**
- 17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts,**
18 **approves and authorizes the implementation and expenditure of the COPS TRGP**
19 **Grant Award No. 2005HEWX0076, and the COPS Budget in the amount of \$569,250 and**
20 **waives the indirect cost as unallowable under the USDOJ.**
- 21 **BE IT FURTHER RESOLVED that the grant award is a two (2) year grant to be effective August 1,**
22 **2005 and ending on July 31, 2007, of which the balance at the end of Fiscal Year 2006**
23 **may be carried forward.**
- 24 **BE IT FURTHER RESOLVED that the matching contribution of 25% which is \$189,750 has been**
25 **identified under the 638 BIA TOPD Budget and that these funds are free of any other**
26 **match to other grants.**
- 27 **BE IT FURTHER RESOLVED by the Tohono O'odham Nation Legislative Council that the Vice-**
28 **Chairman is authorized to accept, negotiate, and execute any documentation**

8 **AGAINST; 389.0 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
9 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
10 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
11 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
12 **Stat. 984).**
