

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution #05-588, "Adopting the Executive Branch Fiscal Year 2006 Budget
and Appropriating Funds in the amount of \$38,963,871.29" to \$38,976,705.87)**

RESOLUTION NO. 05-697

1 **WHEREAS, the Executive Branch prepared and presented the Fiscal Year 2006 budget to the**
2 **Tohono O'odham Legislative Council; and**

3 **WHEREAS, the Facilities Management appropriation of \$774,500.32 was incorrect by an amount**
4 **of \$12,834.58 and should read as \$787,334.90; and**

5 **WHEREAS, the correction has been presented to the Budget and Finance Committee and the**
6 **Budget and Finance Committee recommended an amendment to the Executive**
7 **Branch Fiscal Year 2006 Budget be presented to the Tohono O'odam Legislative**
8 **Council.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby retroactively amend**
10 **the Executive Branch Fiscal Year 2006 budget from \$38,963,871.29 to \$38,976,705.87**
11 **to reflect the correction of the Facilities Maintenance Budget effective October 1,**
12 **2005.**

13 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
14 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official**
15 **are authorized to negotiate and execute the budget, provided however, that any**
16 **amendments affecting the funds or funding levels of the budget shall be submitted**
17 **for further prior approval.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH Day**
19 **of NOVEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**
