4	approved by the voters, will generate \$2.1 billion over the next 20 years; and
5	WHEREAS, the RTA has completed a 20-year plan consisting of transit, Intersection Safety,
6	Elderly and Pedestrian Pathways and Bike, Bridge improvements, and other
7	transportation related projects; and
8	WHEREAS, the proposed RTA plan will impact the Tohono O'odham Nation primarily the
9	transportation improvements being made adjacent to the San Xavier District.
10	NOW ,THEREFORE, BE IT RESOLVED that the Legislative Council has reviewed the Regional
11	${\bf Transportation Authority Excise Tax Expenditure Plan and recommends its support.}$
12	BE IT FURTHER RESOLVED, that continued consultation be made with the Tohono O'odham Nation
13	on this plan as it is executed by the Regional Transportation Authority.
14	BE IT FINALLY RESOLVED, that the Chairwoman of the Nation or her designee ensure the intent
15	of this resolution.
