

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Continuing Resolution for the Chukut Kuk District FY 2005 Budget)

RESOLUTION NO. 05-707

1 **WHEREAS, the Tohono O'odham Legislative Council did approve a continuing resolution for the**
2 **Chukut Kuk District 2005 Budget (TOLC Resolution No. 05-599) for an additional 60**
3 **days; and**

4 **WHEREAS, the 60 days approved in TOLC Resolution No. 05-599 did expire; and**

5 **WHEREAS, the Chukut Kuk District did meet with the Tohono O'odham Legislative Budget &**
6 **Finance Committee on November 28, 2005 to present it's proposed FY 2006 Budget;**
7 **and**

8 **WHEREAS, the Chukut Kuk District did present it's proposed FY 2006 Budget to the Tohono**
9 **O'odham Legislative Council at a Special Session on November 29, 2005; and**

10 **WHEREAS, there were some areas of concern regarding the proposed budget & draft resolution;**
11 **and**

12 **WHEREAS, Chukut Kuk District Budget proposed for FY 2006 budget did not get approved; and**


13 **WHEREAS, it was acted on and approved by the Tohono O'odham Legislative Council for another**
14 **continuing resolution for an additional 30 days.**

15 **NOW ,THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves a**
16 **Continuing Resolution for the Chukut Kuk District Budget for FY 2005 for an**
17 **additional 30 days.**

18 **BE IT FINALLY RESOLVED that the Chukut Kuk District Council will present their proposed FY 06**
19 **budget to the Tohono O'odham Legislative Council during the December 2005**
20 **General Session of the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH Day**
22 **of NOVEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (d)(2), (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**




