

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Representative Marlene Saraficio Juan to Committee Memberships)**

LEGISLATIVE ORDER NO. 05-710

1 **WHEREAS, the Constitution of the Tohono O'odham Nation empowers the Legislative Council to**
2 **“establish rules and procedures to regulate all meetings of . . . standing committees”**
3 **and to “appoint, or provide for the appointment of, and prescribe the duties and**
4 **powers of committees” (Constitution, Article VI, Section 1(a) and (b)); and**

5 **WHEREAS, on December 1, 2005, Legislative Council Representative Dennis E. Jose was removed**
6 **from office pursuant to Legislative Order No. 05-708, thereby leaving a vacancy on**
7 **each of the following Legislative Council standing committees: Appropriations,**
8 **Budget and Finance, Housing, and Commerce; and**

9 **WHEREAS, pursuant to Article XI, Section 6.3. of the Uniform Election Ordinance, when a**
10 **Legislative Council representative's seat becomes vacant, “the alternate of that**
11 **representative shall immediately succeed to the office of the representative”; and**

12 **WHEREAS, Marlene Saraficio Juan was appointed by the Sells District Council Res. SD-37-05, to**
13 **serve as Dennis E. Jose's alternate and she therefore succeeded to his office as a**
14 **Legislative Council representative on December 1, 2005; and**

15 **WHEREAS, as a matter of practice, the Legislative Council has appointed a Legislative Council**
16 **representative's successor to the former representative's vacant committee seats.**

17 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that**
18 **it hereby appoints Councilwoman Marlene Saraficio Juan to the Legislative Council**
19 **Appropriations, Budget and Finance, Housing, and Commerce Committees.**

20 **BE IT FINALLY ORDERED that Legislative Orders No. 05-261, 05-262, 05-267, and 05-280**
21 **(appointing, respectively, Appropriations, Budget and Finance, Housing, and**
22 **Commerce Committee members) are hereby amended to the extent that**
23 **Councilwoman Marlene Saraficio Juan is appointed to former Councilman Dennis E.**
24 **Jose's committee memberships effective immediately.**

25 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 05TH Day of**
26 **DECEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1(a) & (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**


