

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Modifying Enrollment Resolution No. 05-002)**

**RESOLUTION NO. 05-712**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "enact laws and**  
2 **ordinances for governing the enrollment and adoption of members and the**  
3 **relinquishment and loss of membership" Constitution of the Tohono O'odham Nation**  
4 **Article VI Section 1(b); and**

5 **WHEREAS, Article VIII Section 1 of the Enrollment Ordinance No. 5-81 (as amended) provides that**  
6 **the Legislative Council shall determine Applicant's eligibility for enrollment or**  
7 **adoption; and**

8 **WHEREAS, on December 06, 2004 the Legislative Council, pursuant to Resolution No. 04-659,**  
9 **approved Analiza A. Castaneda, with Roll No. 5108-S-04 for membership in the Tohono**  
10 **O'odham Nation; and**

11 **WHEREAS, on January 03, 2005 the Legislative Council pursuant to Resolution No. 05-002,**  
12 **approved Leo Antone Jr., Roll No. 5108-S-04 for membership in the Tohono O'odham**  
13 **Nation; and**

14 **WHEREAS, the Enrollment Manual at page 5, (*Filling of Applications*) provides that once a**  
15 **number has been assigned to an application it shall not be changed; and**

16 **WHEREAS, the Enrollment Committee has determined that Leo Antone Jr. was mistakenly given**  
17 **the same roll number as Analiza A. Castaneda; and**

18 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O'odham**  
19 **Legislative Council shall cause the membership roll be kept current.**

20 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 21           **1. The Tohono O'odham Legislative Council approves a modification of**  
22           **Resolution No. 05-002 as follows: by assigning Leo Antone Jr. to Roll No. 5127-S-**  
23           **04. This roll number is determined by the last application number assigned**  
24           **for Sells District in 2004.**
- 25           **2. The Enrollment Committee shall make the necessary changes in the records**  
26           **of the Enrollment Office to incorporate the stated modification resolution.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>th</sup>. Day**  
28 **of DECEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article**  
30 **II and Article V, Section 2 (f) of the Constitution of the Tohono O'Odham Nation, adopted by the**  
31 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat. 984).**
