

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Modifying Enrollment Resolution No. 03-380)**

RESOLUTION NO. 05-713

1 **WHEREAS, the Legislative Council is vested with the power to “enact laws and ordinances for**
2 **governing the enrollment and adoption of members and the relinquishment and loss**
3 **of membership” (Constitution of the Tohono O’odham Nation, Article VI, Section 1(b));**
4 **and**

5 **WHEREAS, Article VIII, Section 1 of the Enrollment Ordinance, Ordinance No. 5-81 (as amended)**
6 **provides that the Legislative Council shall determine applicant’s eligibility for**
7 **enrollment or adoption; and**

8 **WHEREAS, on October 06, 2003 the Legislative Council, pursuant to Resolution No. 03-463,**
9 **approved Nokomis M. Sweeney, with Roll No. 3894-B-03 for membership in the**
10 **Tohono O’odham Nation; and**

11 **WHEREAS, on September 08, 2003 the Legislative Council, pursuant to Resolution No. 03-380,**
12 **approved Dontrell Johnathan Bird with Roll No. 3894-B-03 for membership in the**
13 **Tohono O’odham Nation; and**

14 **WHEREAS, the Enrollment Manual at page 5, (Filing of Applications) provides that once a number**
15 **has been assigned to an application it shall not be changed; and**

16 **WHEREAS, the Enrollment Committee has determined that Dontrell Johnathan Bird was**
17 **mistakenly given the same roll number as Nokomis M. Sweeney; and**

18 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O’odham**
19 **Legislative Council shall cause the membership roll to be kept current.**

20 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 21 **1. The Tohono O’odham Legislative Council approves a modification of Resolution**
22 **No. 03-380 as follows: by assigning Dontrell Johnathan Bird to Roll No. 3893-B-03.**
23 **This roll number is determined by the last application number assigned for**
24 **Baboquivari District in 2003.**
- 25 **2. The Enrollment Committee shall make the necessary changes in the records of**
26 **the Enrollment Office to incorporate the stated modification.**

27 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 05th. Day**
28 **of DECEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article**
30 **II and Article V, Section 2 (f) of the Constitution of the Tohono O’Odham Nation, adopted by the**
31 **Tohono O’Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat. 984).**
