2 **Tohono O'odham Nation, namely:**



9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> Day**  
10 **of DECEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
11 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article**  
12 **II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation,**  
13 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
14 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**  
15 **of June 18, 1934 (48 Stat. 984).**




