

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Certifying Commerce and Budget and Finance Committee Vice Chairpersons)

LEGISLATIVE ORDER NO. 05-721

1 **WHEREAS, on December 1, 2005, Legislative Council Representative Dennis E. Jose was removed**
2 **from office pursuant to Legislative Order No. 05-708; and**

3 **WHEREAS, prior to his removal, Representative Jose was elected to the office of vice chairman**
4 **of both the Commerce Committee and Budget and Finance Committee; those offices**
5 **became vacant due to his removal; and**

6 **WHEREAS, individual Legislative Council standing committees are empowered to caucus and**
7 **elect committee officers (Legislative Rules of the Tohono O'odham Legislative**
8 **Council, Article XII, Section 3.J.); and**

9 **WHEREAS, the Commerce Committee did caucus on December 5, 2005 and elected**
10 **Representative Frances Conde as Vice Chairwoman; and**

11 **WHEREAS, the Budget and Finance Committee did caucus on December 5, 2005 and elected**
12 **Representative Gerald Fayuant as Vice Chairman.**

13 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**
14 **certifies Representative Frances Conde as Vice Chairwoman of the Commerce**
15 **Committee effective immediately.**

16 **BE IT FURTHER ORDERED by the Tohono O'odham Legislative Council that it hereby certifies**
17 **Representative Gerald Fayuant as Vice Chairman of the Budget and Finance**
18 **Committee effective immediately.**

19 **BE IT FINALLY ORDERED that Legislative Order No. 05-300, "Certification of Legislative Committee**
20 **Officers," is hereby amended to certify the election of Representative Frances Conde**
21 **as the Commerce Committee Vice Chairwoman and Representative Gerald Fayuant**
22 **as the Budget and Finance Committee Vice Chairman.**

23 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 05TH Day of**
24 **DECEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1(a) & (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
