

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriating Funds from the Interest in the Southern Arizona Water Rights
Settlement Act Trust Fund for the Purchase of Heavy Equipment for the Range
Conservation and Management Program)**

RESOLUTION NO. 05-724

1 **WHEREAS, the Range Conservation and Management Program has been created to develop,**
2 **conserve, and manage the Nation's rangelands and has been directed by the Nation's**
3 **Natural Resources Department to mitigate flooding and drought issues on the Nation;**
4 **and**

5 **WHEREAS, the Range Conservation and Management Program has used surplus funding to rent**
6 **heavy equipment from June-December 2005 to provide flood and drought mitigation;**
7 **and**

8 **WHEREAS, the Range Conservation and Management Program is in need of new or recently used**
9 **heavy equipment to carry out its functions to enhance the Nation's rangelands for**
10 **livestock and wildlife; and**

11 **WHEREAS, the Range Conservation and Management Program has requested that the Tohono**
12 **O'odham Nation appropriate \$1,482,255.80 from the interest in the SAWRSA Trust**
13 **Fund to purchase recently used and new heavy equipment in accordance with the**
14 **attached Range Conservation and Management Program FY 2006 Budget; and**

15 **WHEREAS, the Tohono O'odham Nation Legislative Agricultural, Water Resources, and the**
16 **Budget and Finance Committees have reviewed this proposal and recommend**
17 **approval by the Tohono O'odham Nation Legislative Council.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**

19 **1. appropriates \$1,482,255.80 from the interest in the SAWRSA Trust Fund for the**
20 **purchase of recently used and new heavy equipment by the Range Conservation**
21 **and Management Program in accordance with the attached Range Conservation**
22 **and Management Program FY 2006 Budget; and**

23 **2. authorizes the Office of the Treasurer to transfer \$1,482,255.80 from the interest**
24 **in the SAWRSA Trust Fund to the General Fund for the purchase of recently used**
25 **and new heavy equipment, in accordance with the Range Conservation and**
26 **Management Program FY 2006 Budget, which is hereby approved, provided**
27 **however, that any amendments affecting the funding or funding levels of the**

attached budget shall be submitted for further prior approval by the Tohono O'odham Legislative Council.


