

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Chukut Kuk District Fiscal Year 2006 Budget)

RESOLUTION NO. 05-735

1 **WHEREAS, the Chukut Kuk District did meet on, December 6, 2005 in Vamori, Chukut Kuk**
2 **District, at which a quorum was present, (per Chukut Kuk District Resolution 2005-**
3 **64, attached hereto); and**

4 **WHEREAS, the Chukut Kuk District Council (District Council) did review the proposed Fiscal Year**
5 **(FY) 2006 Budget, (attached hereto); and**

6 **WHEREAS, the District Council did approve by Resolution No. 2005-64, the Chukut Kuk District**
7 **FY 2006 Budget, in the amount of \$1,103,185.32, (Beginning October 1, 2005 -**
8 **September 30, 2006); and**

9 **WHEREAS, per District Resolution No. 2005-63, the District Council did authorize community**
10 **budgets in the amount of \$13,500.00, per community; and**

11 **WHEREAS, the Chukut Kuk District is requesting that the Chukut Kuk District FY 2006 Budget**
12 **attached hereto be authorized to be retroactive to October 1, 2005 and ending on**
13 **September 30, 2006; and**

14 **WHEREAS, the Chukut Kuk District did receive from the Gaming Revenue distributions,**
15 **including interest earned, the total amount of \$1,109,796.73; and**

16 **WHEREAS, the attached Budget & Draft Resolution was presented to and reviewed by the Tohono**
17 **O'odham Legislative Council, Budget & Finance Committee.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
19 **and authorizes expenditure of the Chukut Kuk District Budget for FY 2006 in the**
20 **amount of \$1,103,185.32, (as attached hereto) and to be funded from Gaming**
21 **Revenue allocations to the District.**

22 **BE IT FURTHER RESOLVED that Chukut Kuk District FY 2006 Budget is hereby authorized to be**
23 **retroactive to October 1, 2005 and ending on September 30, 2006.**

24 **BE IT FURTHER RESOLVED that this resolution of the Tohono O'odham Legislative Council No. 05-**
25 **735, hereby supercedes and repeals Tohono O'odham Legislative Council Resolutions**
26 **No. 05-599 and Resolution No. 05-707.**

27 **BE IT FINALLY RESOLVED that any amendments affecting the funding or funding levels of the**
28 **attached budget shall be submitted for further prior approval by the Tohono**
29 **O'odham Legislative Council.**




