RESOLUTION NO. 05-741

1 **WHEREAS, by Resolution No. 05-558, Legislative Council approved allocation of \$88,561.36 for**
2 **Account No. 01-1300, Tribal Family Assistance Budget; and**

3 **WHEREAS, the Nation is requesting from the Bureau of Indian Affairs (BIA) for additional Welfare**
4 **Assistance Grant (WAG) funding beyond the \$1,711,497.00 received in FY 2006 at this**
5 **time, in order to meet the need to provide direct services to clients beyond the**
6 **"6-month" FY 2006 BIA WAG budgets approved by Resolution No. 05-590; and**

7 **WHEREAS, the Executive Branch has prepared its Fiscal Year 2006 budget requests for additional**
8 **Tribal funds from savings, and presented these to the Tohono O'odham Legislative**
9 **Council:**

18 **the above program budgets when additional FY 2006 BIA WAG funds are received;**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
20 **appropriate from the Desert Diamond Gaming Savings Account in the amount of**
21 **\$1,006,534.58 and authorize the Executive Branch to expend funds for the FY 2006**
22 **Tribal Budgets attached for this FY 2006 only, effective October 1, 2005 through**
23 **September 30, 2006, inclusive of budget modifications during this period, in the**






