2	re-classify the Baboquivari District Vice-Chairman's position to an Administrative
3	Assistant position and also the approval of monetary Christmas gifts to all Baboquivari
4	Legislative and District Council representatives and their alternates, all district and
5	community employees; and
6	WHEREAS, a job description for the Administrative Assistant was also approved at the November
7	29, 2005 meeting as well as utilizing savings from the Baboquivari District Savings
8	Account (Account #1067509) , for Christmas gifts to employees; and
9	WHEREAS, the amount of \$21,500.00, from the Savings Account, will be added to line item 852.32
10	of the Baboquivari District Administration FY 06 Annual Budget of \$439,371.52.
11	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does approve
12	the re-classification of the Vice-Chairman's position to an Administrative Assistant
13	position in the amount of \$28,120.00 (Salary @ \$22,496.00 + Fringe Benefits @ \$5,624.00)
14	and the transfer of funds from the Baboquivari Savings Account, in the amount of
15	\$21,500.00, to the Baboquivari District Administration FY 06 Budget, for a total of
16	\$460,871.52.
17	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u>09<sup>TH</sup>.</u> Day
18	of <u>DECEMBER</u> , 2005 at a meeting at which a quorum was present with a vote of $2,271.8$ FOR; $-0$
19	AGAINST; 169.0 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by
20	Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
21 22	Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
23	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
