16		2.	I he limited waiver of sovereign immunity shall be effective on the date the Nation					
17		i	and the Construction Contractor execute the Construction Contract in					

substantially the form attached hereto.

Day of DECEMBER, 2005 at a meeting at which a quorum was present with a vote of 1,833.1 FOR; 421.0 AGAINST; 186.7 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
