

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Enrollment Resolution No. 04-438)**

**RESOLUTION NO. 06-005**

- 1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the**  
2 **power to "enact laws and ordinances for governing the enrollment and adoption of**  
3 **members and the relinquishment and loss of membership" Art. VI, § 1(h); and**  
4 **WHEREAS, the Enrollment Ordinance enacted by the Legislative Council provides that the**  
5 **Legislative Council shall determine applicant's eligibility for enrollment or adoption,**  
6 **Art. VIII, § 1; and**  
7 **WHEREAS, on September 13, 2004 the Enrollment Committee presented the enrollment**  
8 **application of Nehemiah Frank to the Legislative Council recommending approval;**  
9 **and**  
10 **WHEREAS, pursuant to Resolution No. 04-438 the Legislative Council approved the enrollment**  
11 **application of Nehemiah Frank with application number 2309-SO-02; and**  
12 **WHEREAS, subsequent to approval it was discovered that the Enrollment Program incorrectly**  
13 **listed the application number of Nehemiah Frank on the membership listing**  
14 **presented to the Legislative Council; and**  
15 **WHEREAS, as a result of this error, Resolution No. 04-438 incorrectly lists the application**  
16 **numbers of Nehemiah Frank; and**  
17 **WHEREAS, the enrollment application of Nehemiah Frank was originally and is now**  
18 **assigned application No. 2306-SO-02; and**  
19 **WHEREAS, the Enrollment Ordinance provides that the Tohono O'odham Legislative Council**  
20 **shall cause the membership roll to be kept current, Art. X, § 3.**

21 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 22 **1. The Legislative Council approves the amendment of Resolution No. 04-438 by**  
23 **changing the application number listed for Nehemiah Frank to application No.**  
24 **2306-SO-02 to reflect the number originally assigned to his application.**  
25 **2. The Enrollment Committee shall make the necessary changes in the records of**  
26 **the Enrollment Office to incorporate the stated amendment.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>th</sup>. Day**  
28 **of JANUARY, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
30 **Section 1 (h) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
31 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat. 984).**
