

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to accept and expend an Animal and Plant Health Inspection Service
grant allocation for the Agriculture Extension Program FY2006 Budget)

RESOLUTION NO. 06-011

1 WHEREAS, the Agriculture Extension Program was awarded an Animal and Plant Health
2 Inspection Service (APHIS) grant to develop a premise identification numbering system
3 for the Tohono O'odham Nation in the amount of \$18,000.00; and

4 WHEREAS, the Agriculture Extension Program budget has been reviewed by the Tohono O'odham
5 Legislative Agricultural Committee and the Budget and Finance Committee and has
6 been recommended to the Tohono O'odham Legislative Council for approval.

7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes
8 the acceptance and expenditure of the APHIS grant in the amount of \$18,000, for the
9 Agriculture Extension Program FY2006 budget, in accordance with the budget attached
10 hereto.

11 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
12 Nation's Official, to wit: the Chairwoman, Vice-Chairman, and any designated official
13 are authorized to negotiate and execute the grant, provided however, that any
14 amendments affecting the funds or funding levels of the grant shall be submitted for
15 further prior approval.

16 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day
17 of JANUARY, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-
18 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section
19 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
20 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
21 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
22 Stat. 984).
