| 9 | this funding be obligated for this sole purpose"; and |
| 10 | WHEREAS, the Budgeted amount of \$97,871.25 per Resolution No. 05-634, appropriated for the |
| 11 | operational expenses of the facilities at the Hia-Ced land base does not provide for the |
| 12 | cost of drilling a well and installing a submersible pump; and |
| 13 | WHEREAS, the Hia-Ced Program, in collaboration with the Hia-Ced Advisory Committee is |
| 14 | requesting an appropriation in the amount of \$70,000.00 to continue in the |
| 15 | development of the Hia-Ced O'odham land base. |
| 16 | NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council appropriates |
| 17 | \$70,000.00 to be transferred from the Hia-Ced O'odham Investment Account and added |
| 18 | to the current Hia-Ced Planning & Development FY 2006 budget of \$97,871.25 for a total |
| 19 | amount of \$167,871.25. |
