5	with conflicts of interest who cannot be represented by the Nation's Advocate Program;

7	WHEREAS, the Advocate Program has presented a contract for John M. Neis which confirms and
8	ratifies the terms and conditions related to his services, a copy of which is attached
9	hereto; and
10	WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee have each
11	reviewed the contract and recommended its submission to the Legislative Council.

13	1. The Tohono O'odham Legislative Council ratifies and approves the Conflict
14	Attorney Contract for John M. Neis in the form attached hereto for the period of
15	October 1, 2005 through September 30, 2006 in an amount not to exceed \$35,000.00
