1	WHEREAS, there are no other attorneys to handle conflicts which the Nation's Advocate Program
2	is not ethically allowed to handle in the increasing needs of tribal members for legal
3	representation in civil and criminal matters; and
4	WHEREAS, the Advocate Program wishes to retain Lawrence O. Boswell to be appointed to
5	represent clients with conflicts of interest who cannot be represented by the Nation's
6	Advocate Program; and
7	WHEREAS, the Advocate Program has presented a contract for Lawrence O. Boswell which
8	confirms and ratifies the terms and conditions related to his services, a copy of which
9	is attached hereto; and
10	WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee have reviewed
11	the contract and recommended its submission to the Legislative Council.
12	NOW, THEREFORE, BE IT RESOLVED THAT;
13	1. The Tohono O'odham Legislative Council ratifies and approves the Conflict
14	Attorney Contract for Lawrence O. Boswell in the form attached hereto for the
15	period of October 1, 2005 through September 30, 2006 in an amount not to exceed
16	\$50,000.00 total.
17	2. Funding for the Conflict Attorney Contract for Lawrence O. Boswell shall be
18	provided under the operating budget of the Advocate Program for fiscal year 2006.
