

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY06 Conflict Attorney Contract for David M. Juarez)**

RESOLUTION NO. 06-022

1 **WHEREAS, there are no other attorneys to handle conflicts which the Nation's Advocate Program**  
2 **is not ethically allowed to handle in the increasing needs of tribal members for legal**  
3 **representation in civil and criminal matters; and**

4 **WHEREAS, the Advocate Program wishes to retain David M. Juarez to be appointed to represent**  
5 **clients with conflicts of interest who cannot be represented by the Nation's Advocate**  
6 **Program; and**

7 **WHEREAS, the Advocate Program has presented a contract for David M. Juarez which confirms and**  
8 **ratifies the terms and conditions related to his services, a copy of which is attached**  
9 **hereto; and**

10 **WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee have each**  
11 **reviewed the contract and recommended its submission to the Legislative Council.**

12 **NOW, THEREFORE, BE IT RESOLVED THAT;**


- 13 **1. The Tohono O'odham Legislative Council ratifies and approves the Conflict**  
14 **Attorney Contract for David M. Juarez in the form attached hereto for the period of**  
15 **October 1, 2005 through September 30, 2006 in an amount not to exceed \$50,000.00**  
16 **total.**
- 17 **2. Funding for the Conflict Attorney Contract for David M. Juarez shall be provided**  
18 **under the operating budget of the Advocate Program for fiscal year 2006.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> Day**  
20 **of JANUARY, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section**  
22 **1 (d)(2)&(3) and 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**




