

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Budget Modification/Amendment #1 to the Advocate Program FY 2006 Budget)**

**RESOLUTION NO. 06-023**

1 **WHEREAS, the Advocate Program wishes to make changes in its personnel positions to better**  
2 **address the Program's increasing demands for legal services; and**

3 **WHEREAS, the Advocate Program has presented a Budget Modification detailing the changes**  
4 **needed to fund these positions and the Program has adequate base funding to**  
5 **accomplish these changes; and**

6 **WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee have each**  
7 **reviewed the Advocate Program's proposed FY06 Budget Modification #1/Amendment**  
8 **#1.**

9 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council approves the**  
10 **FY2006 Advocate Program's Budget Modification/Amendment #1 as follows:**

- 11 **1. The elimination of two Advocate Attorney I positions, numbers 01-1035-007-361 and**  
12 **01-1035-008-361;**
- 13 **2. The funding of three previously created full-time Advocate positions;**
- 14 **3. The elimination of one full-time Advocate Attorney II position, 01-1035-005-362;**
- 15 **4. The creation and funding of two permanent part-time (20+ hours per week)**  
16 **Advocate Attorney II positions;**
- 17 **5. The reclassification of the legal secretary position #01-1935-013-351 to supervising**  
18 **legal secretary;**
- 19 **6. The creation and funding of a new secretary position;**

20 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves and authorizes**  
21 **the Advocate Program FY2006 Budget Modification/Amendment #1.**

22 **BE IT FINALLY RESOLVED THAT any amendments affecting the funding levels of this budget shall**  
23 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> Day**  
25 **of JANUARY, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section**  
27 **1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
30 **Stat. 984).**
