(Approving Funding to the San Xavier Cooperative Association for Personnel and Payroll Expenses for Fiscal Year 2006)

1	WHEREAS,	the Tohono O'odham Nation is the recipient of the Southern Arizona Water Rights					
2		Settlement Act (SAWRSA) Trust Fund; and					
3	WHEREAS,	one of the funding priorities established for the SAWRSA Fund is to fund the costs					
4		associated with land subjugation for the SXCA Farm (TOLC Resolution 92-156); and					
5	WHEREAS,	SAWRSA provides for the rehabilitation and improvements of the SXCA Cooperative					
6		Farm; and					
7	WHEREAS,	this rehabilitation construction project is scheduled to begin in January 2006, which					
8 ·		will increase the current farm acreage of 250 acres to 949 acres; and					
9	WHEREAS,	it is necessary that the SXCA Farm continue to operate in order to provide experience					
10		and training for Farm personnel to become a skilled and knowledgeable workforce					
11		for the completed rehabilitation of the Farm in 2007; and					
12	WHEREAS,	the San Xavier Cooperative Association (SXCA) has requested and received funding					
13		from the Southern Arizona Water Rights Settlement (SAWRSA) Trust Fund; and					
14	WHEREAS,	such funds in the past have provided for operational and capital needs of the SXCA					
15		Farm; and					
16	WHEREAS,	in June 2005, per Resolution #05-345, the SXCA received \$149,056.36 for 4-months for					
17		personnel, office computers and farm equipment; and					
18	WHEREAS,	the SXCA submitted a budget proposal for Fiscal Year 2006 for Farm Personnel and					
19		Payroll Expenses totaling \$384,593.73 to continue farm operations; and					
20	WHEREAS,	SXCA has submitted this funding request to the Tohono O'odham Legislative Budget					
21		and Finance, Agriculture and Water Resources Committees for their review and					
22		recommendations.					
23	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves						
24		the San Xavier Cooperative Association funding request in the amount of \$384,593.73					
25		for Personnel and Payroll Expenses for the 2006 Fiscal Year from the SAWRSA Trust					
26		Fund as described in the attached budget proposal.
