1 **WHEREAS, the authorized expenditure period for the Department of Health & Human Services**  
2 **Native Employment Works is July 1, 2005 through June 30, 2006; and**

3 **WHEREAS, the Department of Health & Human Services - Native Employment Works Annual**  
4 **Budget Modification/Amendment #2, have been changed to reflect the addition of**  
5 **two (2) program staff positions of an Intake Specialist and a Quality Assurance**  
6 **Supervisor and the re-classification of a program van driver to the Follow Up**  
7 **Supervisor; and**

8 **WHEREAS, the budget modification/amendment # 2 approves these positions and any retro**  
9 **salaries effective January 1, 2006.**


10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
11 **approve the Department of Health & Human Services Native Employment Works**  
12 **Budget PY 2005 Modification/Amendment #2 in the allocation amount of \$150,868.00**  
13 **with the addition of two (2) additional staff positions and a re-classification of a**  
14 **program van driver to the Follow Up Supervisor.**

15 **BE IT FURTHER RESOLVED the salary changes are retro active effective January 1, 2006 for the**  
16 **re-classified position.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
18 **Nation's Officials, to wit; the Chairwoman is hereby authorized to negotiate and**  
19 **execute the contracts and plans, provided however, that any amendment affecting**  
20 **the funding or funding levels of this contract shall be submitted for further prior**  
21 **approval by the Tohono O'odham Nation Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>th</sup> Day**  
23 **of JANUARY, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
25 **Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
28 **Stat. 984).**
