RESOLUTION NO. 06-032

1 WHEREAS, the Department of Arizona Economic Security – Adult and Youth PY 05-FY06 Annual
2 Contract and Budget Amendment/Modification #2 final allocation of \$301,190.00
3 beginning June 1, 2005 and ending June 30, 2008; and

4 WHEREAS, the State of Arizona Department of Economic Security – Adult and Youth PY 05/FY06
5 annual contract and budgets amendment/modification #2, have been changed to
6 reflect the addition of two (2) program staff positions of an Intake Specialist and a
7 Quality Assurance Supervisor and the re-classification of a program van driver to the
8 Follow Up Supervisor; and

9 WHEREAS, the budget modification/amendment # 2 approves these positions and any retro
10 salaries effective January 1, 2006.


11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
12 approve the Employment & Training Annual State of Arizona – Department of Economic
13 Security Budgets Amendment/Modification #2 and Contract PY 2005/FY 2006 in the final
14 allocation amount of \$301,190.00 with addition of two (2) additional staff positions and a re-
15 classification of a program van driver to the Follow Up Supervisor.


16 BE IT FURTHER RESOLVED the salary changes are retro active effective January 1, 2006 for the
17 re-classified position.

18 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
19 Nation's Officials, to wit; the Chairwoman is hereby authorized to negotiate and execute the
20 contracts and plans, provided however, that any amendment affecting the funding or
21 funding levels of this contract shall be submitted for further prior approval by this Tohono
22 O'odham Legislative Council.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11th. Day
24 of JANUARY, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-
25 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
26 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
27 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
28 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
29 Stat. 984).
