9		Section 6(B)(2)); and
10	WHEREAS,	Section 6(C) of the TERO Ordinance further provides that "Commissioners shall be
11		appointed for terms of three years, or until their successors are appointed and
12		qualified, provided, however, that appointments to the Commission shall be made
13		in such a way and for such terms that their terms shall be staggered so that the terms
14		of office of only two Commissioners will end in any single year."; and
15	WHEREAS,	EvanThomaswasappointedtotheCommissionwithatermendingJune30,2005, and

18	WHEREAS,	the Domestic Affairs Committee has been delegated authority to "review and
19		recommend action by the Legislative Council on appointments of TERO
20		Commissioners" (Plan of Operation for the Domestic Affairs Committee, Article III.
21		D. as adopted by Legislative Order No. 01-431); and
22	WHEREAS,	the Domestic Affairs Committee has interviewed qualified TERO Commission
23		applicant and recommends the appointment of Evan Thomas as a member of the
24		Commission commencing upon the effective date of this Resolution and ending June
25		30, 2008, or until his successor is appointed and qualified.

27		Evan Thomas to the TERO Commission commencing upon the effective date of this
