

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment for Final Allocation to the FY 2006 Bureau of Indian Affairs
Judicial Service Contract Under P.L. 93-638)

RESOLUTION NO. 06-074

1 WHEREAS, the Tohono O'odham Legislative Council approved under Resolution No. 05-590 at
2 \$340,947.91 for Judicial Services; and

3 WHEREAS, the FY 2006 Final Allocation amount under P.L. 93-638 for Judicial Services is
4 \$326,756.52 which is less \$12,048.04; and

5 WHEREAS, in order to comply with this reduction, the position of Office Support Worker under
6 this contract was eliminated; and

7 WHEREAS, this budget amendment has been reviewed by the Tohono O'odham Judiciary and
8 Budget & Finance Committees.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
10 approves an amendment to the FY 2006 Bureau of Indian Affairs Judicial Services
11 Budget to reflect a total allocation of \$326,756.52.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH of
13 FEBRUARY, 2006 at a meeting at which a quorum was present with a vote of 2,200.65 FOR; -0-
14 AGAINST; 240.15 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
15 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
16 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18 18, 1934 (48 Stat. 984).




