

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointing Rachel Frazier Strachan Judge Pro Tempore of the Tohono O'odham  
Judicial Courts)**

**RESOLUTION NO. 06-080**

1 **WHEREAS, the Legislative Council is empowered by Article VIII, Section 4 of the Constitution of**  
2 **the Tohono O'odham Nation to appoint judges of the Tohono O'odham Courts; and**

3 **WHEREAS, the Legislative Council did by Ordinance No. 01-89, Chapter II, authorize the**  
4 **appointment of judges pro tempore to the Tohono O'odham Courts upon the**  
5 **recommendation of the Chief Judge; and**

6 **WHEREAS, the Chief Judge has submitted the name of an attorney qualified pursuant to 2-103 of**  
7 **Ordinance No. 01-89 and recommended the appointment as judge pro tempore of the**  
8 **Tohono O'odham Judicial Courts; and**

9 **WHEREAS, Ordinance 01-89, Chapter II allows the appointment of judges pro tempore for terms**  
10 **no greater than six years; and**

11 **WHEREAS, the Chief Judge has submitted the name of one attorney qualified to fill the current**  
12 **expired term of judge pro tempore; and**

13 **WHEREAS, the Judiciary Committee has met with the Chief Judge and discussed the**  
14 **qualifications of the individual who is being recommended for appointment of judge**  
15 **pro tempore; and**

16 **WHEREAS, the Judiciary Committee has determined that the person recommended is of good**  
17 **moral character, resident of the State of Arizona for not less than five years, and is**  
18 **admitted to the practice of law for not less than three years; and**

19 **WHEREAS, the Judiciary Committee does concur with the recommendations of the Chief Judge**  
20 **and recommends to the full Legislative Council one appointment of a judge pro**  
21 **tempore for the Judicial Court of this Nation.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does accept**  
23 **the recommendation of the Chief Judge and, in accordance with Judicial Branch**  
24 **Rules and Procedures formally adopted pursuant to Ordinance 01-89, Chapter II,**  
25 **hereby appoints the following named person with the respective term as judge pro**  
26 **tempore of the Tohono O'odham Judicial Court:**

28 **Rachel Frazier Strachan beginning March 01, 2006 and ending February 28, 2010.**

6 **Section 4 of Article VIII of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
7 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
8 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
9 **Stat. 984).**


