9	WHEREAS,	the legislative officers have exercised this authority by contracting with Valiant				
10		Enterprises, Inc. to conduct a market-based compensation study of Legislative				
11		Branch salaries and wages; and				
12	WHEREAS,	in its final report, Valiant Enterprises, Inc. concluded that "the Legislative Branch is				
13		generally offering salaries that are competitive with the marketplace" and				
14		recommended that all positions be classified and compensated in accordance with				
15		Valiant's proposed Nonexempt Wage Structure and Exempt Wage Structure.				
16	6 NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby					
17		approves the Nonexempt Wage Structure and Exempt Wage Structure for Legislative				
18		Branch employees as proposed by Valiant Enterprises, Inc., provided that (1) the				
19		Structures may be amended to reflect annual compensation and other adjustments				
20		authorized by the Council and (2) any adjustments to Legislative Branch employees'				
21		current salaries which require a modification of or amendment to the FY 2006				
22		Legislative Branch Budget shall be submitted for approval by Legislative Council
