4 **Mileage - 661 line item, Communication Expense - 711 line item, Uniforms - 723 line**

5 **item, and Repair & Maintenance of Building - 772 line item to its FY 2006 Salaries - 610**

6 **line item, Computer Maintenance - 774 line item, Professional Services - 810 line**

7 **item, Public Relations - 812 line item and Food - 850 line item through the end of**

8 **Fiscal Year 2006 as part of the proposed FY 2006 Legislative Branch Budget**

9 **Modification/Amendment No. 1 which is hereby incorporated by this reference; and**

10 **WHEREAS, the FY 2006 Legislative Branch Budget Modification/Amendment No. 1 also reflects**

11 **salary increases for the Office Support Worker and Legal Secretary in accordance**

12 **with the Legislative Branch Compensation Study; and**

13 **WHEREAS, this proposed modification/amendment would not increase or decrease the total**

14 **amount of the Tohono O'odham Legislative Branch FY 2006 Budget; and**

15 **WHEREAS, the Budget and Finance Committee did review the proposed FY 2006 Legislative**

16 **Branch Budget Modification/Amendment No. 1.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**

18 **the FY 2006 Legislative Branch Budget Modification/Amendment No. 1.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH, of**
20 **FEBRUARY, 2006 at a meeting at which a quorum was present with a vote of 2,050.2 FOR; -0-**
21 **AGAINST; 221.6 NOT VOTING; and 169.0 [06] ABSENT, pursuant to the powers vested in the Council**
22 **by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**




