| 13 | WHEREAS,   | the Nation requires that all financial and other information provided to Wells Fargo  |
| 14 |            | be maintained in strict confidence; and   |
| 15 | WHEREAS    | Wells Fargo did offer the Nation a Confidentiality Agreement under which Wells Fargo  |
| 16 |            | would agree to hold confidential any financial or other information the Nation would  |
| 17 |            | provide; and  |
| 18 | WHEREAS,   | the Nation's Investment Committee has reviewed the Confidentiality Agreement and      |
| 19 |            | recommends its approval.  |
| 20 | NOW, THER  | EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves     |
| 21 |            | the Confidentiality Agreement between Wells Fargo and the Tohono O'odham Nation       |
| 22 |            | in the form attached hereto.  |
| 23 | BE IT FURT | HER RESOLVED that the Tohono O'odham Legislative Council authorizes the release       |
| 24 |            | of confidential information that the Investment Committee deems necessary to          |
