

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Department of Health and Human Services, Division of Family Assistance – FY06 Food Distribution Program Nutrition Education Budget Amendment #1 - Account No. 11-1316)**

**RESOLUTION NO. 06-124**

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**  
2 **Assistance Division, Food Distribution Program under an FY2006 grant with the**  
3 **United States Department of Agriculture (USDA); and**

4 **WHEREAS, the Food Distribution Program has been beneficial in providing food packages**  
5 **(commodity foods) and nutrition education to eligible households through tailgate**  
6 **runs throughout the Nation and nearby towns; and**

7 **WHEREAS, by Resolution Number 05-567, Tohono O'odham Legislative Council approved the**  
8 **FY06 Nutrition Education budget in the amount of \$1,939.00; and**

9 **WHEREAS, the nutrition education funds available to the Tohono O'odham Nation for FY2006**  
10 **through the USDA has been reduced by \$70.00 from \$1,939.00 to \$1,869.00; and**

11 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**  
12 **Division, Food Distribution Program has submitted the FY2006 Nutrition Education**  
13 **funding budget amendment No#1 in the amount of \$1,869.00 to reflect the reduction**  
14 **in funding, for review and approval.**

15 **NOW, THEREFORE BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 16 **1. It hereby approves and authorizes the FY2006 Food Distribution Nutrition**  
17 **Education budget Amendment #1 in the amount of \$1,869.00, which reflects the**  
18 **final allocation award and authorizes expenditures in accordance with the**  
19 **attached budget.**
- 20 **2. That the Tohono O'odham Nation's official to wit: The Chairwoman is hereby**  
21 **authorized to negotiate and execute the grant, provided however that any**  
22 **amendments affecting the funding levels of this grant shall be submitted for**  
23 **further prior approval.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>, of**  
25 **MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
30 **Stat. 984).**


