

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2005-2006 U.S. Department of Health and Human Services Title IV-B,
Subparts 1 & 2 Budgets)

RESOLUTION NO. 06-125

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **U.S. Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a**
4 **Division of Child Welfare Services to intervene against child abuse and neglect and**
5 **to promote safe and stable families; and**

6 **WHEREAS, the Title IV-B, Subparts 1 & 2 grants require a 25% match, which the Nation matches**
7 **through the P.L. 93-638 Master Contract, as authorized by P.L. 93-638 and the U.S.**
8 **Department of Health and Human Services; and**

9 **WHEREAS, in Resolution No. 04-640, the Legislative Council approved:**

- 10 **1. \$111,767.00 for FY05 Title IV-B, Subpart 1 Budget Acct. 11-1331.**
11 **2. \$107,190.00 for FY05 Title IV-B, Subpart 2 Budget Acct. 11-1332; and**

12 **WHEREAS, these Title IV-B, Subparts 1 & 2 Budgets are authorized for only a two-year**
13 **expenditure period, beginning October 1, 2004 and ending September 30, 2006,**
14 **funding only the two fiscal years of FY 2005 and FY 2006; and**

15 **WHEREAS, the Department of Health and Human Services has determined a final allocation**
16 **amount for these budgets as:**

- 17 **1. \$130,319.00 for Title IV-B, Subpart 1 Budget, Acct. 11-1331.**
18 **2. \$125,340.00 for Title IV-B, Subpart 2 Budget, Acct. 11-1332; and**

19 **WHEREAS, the Division of Child Welfare Services had partially expended these funds as**
20 **authorized in FY 2005, leaving the following remaining balances available in FY 2006**
21 **for these budgets:**

- 22 **1. \$72,465.04 for FY06 Title IV-B, Subpart 1 Budget Acct. 11-1331.**
23 **2. \$79,715.12 for FY06 Title IV-B, Subpart 2 Budget Acct. 11-1332; and**

24 **WHEREAS, the Executive Branch developed and obtained committee approval of the budgets**
25 **attached and incorporated by this reference, to be effective October 1, 2005 through**
26 **September 30, 2006 and requests authorization to expend the remaining funds in FY**
27 **2006.**


1 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
2 approve and authorize the Executive Branch to expend funds for the remaining
3 balances as per the budgets attached, effective October 1, 2005 through September
4 30, 2006, in the following amounts:

- 5 1. \$72,465.04 for FY06 Title IV-B, Subpart 1 Budget Acct. 11-1331.
6 2. \$79,715.12 for FY06 Title IV-B, Subpart 2 Budget Acct. 11-1332.


7 BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairwoman, Vice-
8 Chairman and any designated official are hereby authorized to negotiate, execute
9 and expend the grant, provided however, that any amendments affecting the funding
10 levels of the grant shall be submitted for further prior approval.

11 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH of
12 MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-
13 AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by
14 Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
15 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
16 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
17 Stat. 984).
