

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2006 Department of Health and Human Services BIA ICWA Family  
Preservation Budget Amendment, Account No. 10-1312)**

**RESOLUTION NO. 06-127**

1 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a**  
2 **Division of Child Welfare Services, Family Preservation Program, to promote safe and**  
3 **stable families in furtherance of the Indian Child Welfare Act; and**

4 **WHEREAS, the Bureau of Indian Affairs (BIA) provides funding in furtherance of the Indian Child**  
5 **Welfare Act, through its P.L. 93-638 Master Contract with the Tohono O'odham Nation;**  
6 **and**

7 **WHEREAS, the Department of Health and Human Services, Division of Child Welfare Services,**  
8 **Family Preservation Program, requests to amend its FY 2006 BIA ICWA – Family**  
9 **Preservation budget approved by Resolution No. 05-590, in the following amounts:**

- 10 **1. Base Allocation = \$164,016.00, Indirect Cost = \$29,178.44, Total = \$193,194.44.**  
11 **2. Carry Forward Savings = \$39,114.60, Indirect Cost = \$0.00, Total = \$39,114.60.**  
12 **3. Creating a Total Budget Allocation of \$203,160.60, Total Indirect Cost of**  
13 **\$29,178.44, with a Total Overall Budget of \$232,309.04; and**

14 **WHEREAS, this budget now contains amended line items and new line items, changing the**  
15 **overall Indirect Cost assessed, as indicated in the attached FY 2006 budget**  
16 **amendment, beginning October 1, 2005 and ending September 30, 2006, in the**  
17 **following amount:**

- 18 **1. Total Budget Allocation of \$203,160.60, Total Indirect Cost of \$25,367.75, with a**  
19 **total Overall Budget of \$228,498.35; and**

20 **WHEREAS, the Executive Branch developed and obtained committee approval of the BIA ICWA**  
21 **Family Preservation budget amendment attached and incorporated by this**  
22 **reference, to be effective October 1, 2005 through September 30, 2006, and requests**  
23 **authorization to expend funds.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
25 **approve and authorize the Executive Branch to expend funds for the FY 2006 BIA**  
26 **ICWA– Family Preservation budget amendment attached, effective October 1, 2005**

1. Total Budget Allocation of \$203,160.60, Total Indirect Cost of \$25,367.75, with a total Overall Budget of \$228,498.35.

**BE IT FINALLY RESOLVED** that the Tohono O'odham Nation's officials to wit: the Chairwoman, Vice-Chairman and any designated official are hereby authorized to negotiate, execute and expend the grant, provided however, that any amendments affecting the funding levels of the grant shall be submitted for further prior approval.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> of MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


