

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Division of Child Welfare Services FY 2006 State IV-B Contract Budget
Amendment, Account No. 12-1313)

RESOLUTION NO. 06-128

1 **WHEREAS, the Tohono O'odham Nation, through the Division of Child Welfare Services, has**
2 **historically operated a Family Preservation Program to promote safe and stable**
3 **families; and**

4 **WHEREAS, the Tohono O'odham Nation has executed a State IV-B Contract, Intergovernmental**
5 **Agreement between the Arizona Department of Economic Security and the Tohono**
6 **O'odham Nation for the term of April 1, 2005 through September 30, 2008, as**
7 **approved by Resolution No. 05-331; and**

8 **WHEREAS, the Tohono O'odham Nation with its Family Preservation Program, under this State**
9 **IV-B Contract, invoices and receives additional funds from the State for services that**
10 **the Family Preservation Program provides to Tohono O'odham families, thereby**
11 **increasing funding which is critically needed for the provision of services, and the**
12 **Nation wishes to increase this Program funding; and**

13 **WHEREAS, the Tohono O'odham Legislative Council approved a FY 2006 State IV-B Contract**
14 **Budget of \$87,960.00 by Resolution No. 05-574, but the State later notified the Nation**
15 **that only \$75,390 funding would be available in FY 2006 for this budget; and**

16 **WHEREAS, the Executive Branch developed and obtained Committee approval of the FY2006**
17 **State IV-B Contract Budget Amendment in the amount of \$75,390.00, attached and**
18 **incorporated by this reference, to be effective October 1, 2005 through September 30,**
19 **2006 and requests authorization to expend these funds in FY 2006.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
21 **approve and authorize the Executive Branch to expend funds for the FY2006 State IV-**
22 **B Contract Budget Amendment attached, effective October 1, 2005 through**
23 **September 30, 2006, in the amount of \$75,390.00, inclusive of budget modifications**
24 **throughout this period.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairwoman, Vice-**
26 **Chairman and any designated official are hereby authorized to negotiate, execute**
27 **and expend the grant, provided however, that any amendments affecting the funding**
28 **levels of the grant shall be submitted for further prior approval.**
