

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2006 Mining Royalty Budgets for Baboquivari Districts (3) Communities,**  
**Topawa, Coldfields, and Fresnal Canyon)**

**RESOLUTION NO. 06-139**

1 **WHEREAS, the Baboquivari District Council did meet on October 26, 2005 and approved the**  
2 **Mining Royalty Distribution in the amount of \$94,138.44 to be divided equally in the**  
3 **amount of \$13,448.34 among the six (6) communities and the Baboquivari District**  
4 **Administration; and**


5 **WHEREAS, the Baboquivari District Council did review and approve the Topawa, Coldfields, and**  
6 **Fresnal Canyon Communities budget on February 25, 2006 in the amount of**  
7 **\$40,345.08 @\$13,448.36 each as attached hereto.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
9 **the FY 2006 Mining Royalty Distribution budgets for the Topawa, Coldfields, and**  
10 **Fresnal Canyon Communities in the amount of \$40,345.08 @\$13,448.36 each ending**  
11 **September 30, 2006.**

12 **BE IT FINALLY RESOLVED that any amendments/modifications affecting the funds or funding**  
13 **levels of the budget shall be submitted for further prior approval.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> of**  
15 **MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,117.65 FOR; -0- AGAINST;**  
16 **323.15 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section (d)(2)**  
17 **& (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
18 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
19 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
20 **Stat. 984).**


