

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Confirming the Nomination of Ms. Malinda N. Folson to the Tohono O'odham Nursing
Care Authority Board of Directors)

RESOLUTION NO. 06-141

1 **WHEREAS, the Tohono O'odham Nursing Care Authority Amended & Restated Charter was**
2 **adopted by Legislative Council Resolution No. 04-122 which requires the Chairperson**
3 **of the Nation to nominate Directors to the Tohono O'odham Nursing Care Authority**
4 **Board of Directors and confirmed by the Legislative Council; and**

5 **WHEREAS, the Chairwoman of the Nation has researched, identified and determined that Ms.**
6 **Malinda N. Folson is both willing and qualified to serve as one of the Directors to the**
7 **Tohono O'odham Nursing Care Authority Board; and**

8 **WHEREAS, the Chairwoman of the Nation does hereby nominate Ms. Malinda N. Folson to the**
9 **Tohono O'odham Nursing Care Authority Board of Directors; and**


10 **WHEREAS, the Legislative Health & Human Services Committee and Legislative Rules Committee**
11 **have both reviewed the Chairwoman's nominee.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby confirms**
13 **the Chairwoman's nomination of Ms. Malinda N. Folson to Tohono O'odham Nursing**
14 **Care Authority Board whose term shall expire on October 30, 2009.**

15 **BE IT FINALLY RESOLVED that Ms. Malinda N. Folson shall exercise authority and possess**
16 **responsibility as granted and described by the Tohono O'odham Nursing Care**
17 **Authority Amended & Restated Charter.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH of**
19 **MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,271.8 FOR; -0- AGAINST;**
20 **169.0 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (b)**
21 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
22 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
23 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


