

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending FY 2006 Projected Revenues Adopted by Resolution No. 05-423, as Amended**  
**by Resolution No. 05-527)**

**RESOLUTION NO. 06-152**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to manage any**  
2 **funds within the exclusive control of the Tohono O'odham Nation" (Constitution of**  
3 **the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and**

4 **WHEREAS, the Legislative Council previously adopted FY 2006 Projected Revenues by Resolution**  
5 **No. 05-423, as amended by Resolution No. 05-527; and**

6 **WHEREAS, it is necessary to amend and increase the FY 2006 projected revenues in order to**  
7 **account for increased investment revenues, adjusted savings, and additional**  
8 **distributions from the Tohono O'odham Gaming Enterprise; and**

9 **WHEREAS, the Budget and Finance Committee is therefore recommending that the FY 2006**  
10 **projected revenues be amended and increased by \$12,417,801, thereby increasing the**  
11 **total FY 2006 surplus to \$16,207,623.31; and**

12 **WHEREAS, the total amount of the FY 2006 projected revenues will increase from \$49,725,304 to**  
13 **a new total of \$62,143,105.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
15 **amends and increases the Nation's FY 2006 projected revenues by \$12,417,801,**  
16 **thereby increasing the total FY 2006 surplus to the amount of \$16,207,623.31 provided**  
17 **that \$1,000,000 shall be obligated for the FY 2007 projected revenues.**

18 **BE IT FINALLY RESOLVED that the FY 2006 projected revenue total is hereby increased**  
19 **from \$49,725,304 to a new total of \$62,143,105 and Resolution No. 05-423 is amended**  
20 **accordingly to reflect this new total projected revenue amount.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup>, of**  
22 **MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,271.8 FOR; -0- AGAINST;**  
23 **169.0 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1**  
24 **(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
25 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
27 **Stat. 984).**




