(Approving FY 2007 Projected Revenues in the Amount of \$47,767,883)

RESOLUTION NO. 06-153


1 WHEREAS, the Budget and Finance Committee and the Executive Office reviewed the revenue  
2 projections and available revenues for FY 2007; and

3 WHEREAS, the Budget and Finance Committee and the Executive Office recommend the  
4 adoption of the FY 2007 revenues projected and available in the amount of  
5 \$47,767,883 to fund the Nation's budget for FY 2007.

6 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it  
7 hereby approves the attached projected revenues in the amount of \$47,767,883 for  
8 the purpose of funding the FY 2007 budgets of the Tohono O'odham Nation.


9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup> of  
10 MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-  
11 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
12 Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
13 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
14 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
15 18, 1934 (48 Stat. 984).




