7	WHEREAS,	the correct amount for fiscal year 2006 should have been approved at E06.01,
8		\$34,569.65; and
9	WHEREAS,	KOHN-FM has prepared and presented to the legislative oversight committees a
10		budget amendment to correct the error, retroactive to October 1, 2005, on the
11		Cultural Affairs Director's salary.
12	NOW, THER	EFORE, BE IT RESOLVED by the Tohono O'odham Nation's Legislative Council that it
13		does hereby approve the KOHN-FM budget amendment, attached and incorporated
14		into this resolution, correcting the error on the Cultural Affairs Director's salary.
15	BE IT FINA	ALLY RESOLVED that the correction on the Cultural Affairs Director's salary is
16		retroactive to October 1, 2005, the beginning of the current fiscal year.
