**RESOLUTION NO. 06-159**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
 2 **Indian Health Service; and**  
 3 **WHEREAS, the Executive has approved and presented the following budgets as attached and**  
 4 **incorporated by this reference, to be effective October 1, 2006 through September 30,**  
 5 **2007 and requests authorization to expend the funds listed below:**

**The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup>. day of MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,134.7 FOR; -0- AGAINST; 306.1 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**






