

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Authorizing Fiscal Year 2007 Initiative Administration Budgets;
Appropriation of Additional Funds to the Reserve)

RESOLUTION NO. 06-160

1 **WHEREAS, Initiative IN-01-97 requires that the Nation provide for the annual administrative**
2 **cost of implementing the provisions of the initiative; and**

3 **WHEREAS, a reserve was established to fund the necessary administrative requirements; and**

4 **WHEREAS, the Executive Branch has prepared a Fiscal Year 2007 budget to continue its Initiative**
5 **Administration; and**

6 **WHEREAS, the total Fiscal Year 2007 Initiative Administration Budget, in the amount of**
7 **\$1,326,575.92 includes:**

14 **WHEREAS, the unexpended balance of the established reserve for fiscal year FY 2006 will be**
15 **returned to the Nation’s Desert Diamond Savings Account; at the end of the fiscal**
16 **year; and**

17 **WHEREAS, an estimate additional amount of \$1,326,575.92 will need to be appropriated from the**
18 **Nation’s Gaming Revenues held in the Nation’s Desert Diamond Savings Account to**
19 **fully fund the proposed Initiative Administration Budget; and**

20 **WHEREAS, the budgets have been presented to the respective Legislative Oversight Committees**
21 **for review.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O’odham Legislative Council that it approves**
23 **the following:**

- 24 **1. The estimated unexpended balance of the established reserve for fiscal year end**
25 **FY 06 is hereby returned to the Desert Diamond Savings Account.**
- 26 **2. An additional amount of \$1,326,575.92 is hereby appropriated to the Initiative**
27 **Administration reserve from the Nation’s Gaming Revenues held in the Nation’s**
28 **Desert Diamond Savings Account to fully fund the Executive Branch Initiative**

3 3. The Executive Branch Fiscal Year 2007 Initiative Administration Budget in the full
4 amount of \$1,326,575.92 is hereby approved and funds are authorized to be
5 expended accordingly.

6 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
7 Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official
8 are authorized to negotiate and expend/administer the FY 2007 Initiative
9 Administration Budget, provided however, that any amendments affecting the funds
10 or funding levels of the budget shall be submitted for further prior approval by the
11 Tohono O'odham Legislative Council.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST day
13 of MARCH, 2006 at a meeting at which a quorum was present with a vote of 1,248.7 FOR; 1,005.4
14 AGAINST; 186.7 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
15 Section 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted
16 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18 18, 1934 (48 Stat. 984).


