

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY-07 Budget for Youth Transportation Art Grant)

RESOLUTION NO. 06-161

1 **WHEREAS, the Planning Department's Transportation Program applied for and received grant**
2 **funding in the amount of \$50,000.00; and**

3 **WHEREAS, this project is funded by a Pima Association of Governments grant to enhance**
4 **community pride by involving District youth in designing public transportation art;**
5 **and**

6 **WHEREAS, the Planning Department is requesting approval of the FY-07 Budget of remaining**
7 **funds in the amount of \$206,023.87; and**

8 **WHEREAS, the grant will be administered by the Planning Department's Transportation**
9 **Program.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**
11 **the budget amount of \$206,023.87 and approves the attached budget in the amount**
12 **of \$206,023.87.**

13 **BE IT FURTHER RESOLVED that the Youth Transportation Art Grant is authorized to expend the**
14 **funds in the amount of \$206,023.87 beginning October 1, 2007.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council, to wit: the Chairwoman,**
16 **Vice-Chairman and any designated official are authorized to negotiate and execute**
17 **the grant, provided however, that any amendments affecting the funds or funding**
18 **levels of the grant shall be submitted for further prior approval by the Tohono**
19 **O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST day**
21 **of MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
24 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**


