

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval to Carry Forward the Allocation of Funds (\$1,098,605.09) for the Construction**  
**of Head Start Facilities to the FY 07 Budget)**

**RESOLUTION NO. 06-162**

1 **WHEREAS, the Division of Early Childhood Development operated Head Start center-based**  
2 **programs for children ages 3 to 5 years of age at centers located in Santa Rosa,**  
3 **Pisinemo, Vaya Chin, San Lucy, San Xavier, Sif Oidak and Sells; and**

4 **WHEREAS, the Division also operated child care center-based services for children ages 6 months**  
5 **- 3 years at the Sells and San Xavier centers; and**


6 **WHEREAS, pursuant to Resolution No. 04-653, the Legislative Council approved an appropriation**  
7 **for the renovation and construction of Early Childhood/Headstart Centers.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
9 **approve and authorize the carry forward in the amount of \$1,098,605.09 in**  
10 **accordance with the Headstart/Child Care Centers Construction Budget effective**  
11 **October 1, 2006 thru September 30, 2007.**

12 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
13 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official**  
14 **are authorized to negotiate and execute the budget, provided however, that any**  
15 **amendments affecting the funds or funding levels of the budget shall be submitted**  
16 **for further prior approval by the Tohono O'odham Legislative Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> day**  
18 **of MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,019.80 FOR; 421.0**  
19 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
20 **Section 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**  
21 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
23 **18, 1934 (48 Stat. 984).**




