

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval to Carry Forward to FY2007 the Allocation of Funds (\$5,681,721.20) for
the Dialysis Clinic Construction Budget)**

RESOLUTION NO. 06-163

1 **WHEREAS, the Tohono O'odham Legislative Council by Resolution No. 05-749 did approve and**
2 **appropriate the maximum cost for the project in the amount of \$5,681,721.20 to be**
3 **budgeted for the Design/Construction of Dialysis Clinic Construction.**

4 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
5 **approve and authorize the carry forward for the maximum cost for the project in the**
6 **amount of \$5,681,721.20 in accordance with Dialysis Clinic Construction Budget**
7 **effective October 1, 2006 thru September 30, 2007.**

8 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
9 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official**
10 **are authorized to negotiate and execute the budget, provided however, that any**
11 **amendments affecting the funds or funding levels of the budget shall be submitted**
12 **for further prior approval by the Tohono O'odham Legislative Council.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST. day**
14 **of MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,161.0 FOR; -0-**
15 **AGAINST; 279.8 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
16 **Section 1 (d)(2)& (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
17 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
19 **18, 1934 (48 Stat. 984).**




