

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval to Accept and Expend the US Bureau of Land Management Grant of \$50,000
for the Solid Waste Management Program FY2007 Undocumented Migrant Waste
Budget 11-1513)

RESOLUTION NO. 06-166

1 **WHEREAS, the lands of the Tohono O'odham Nation have been severely impacted by the large**
2 **amount of waste left by undocumented migrants; and**

3 **WHEREAS, the Solid Waste Management Program is responsible for the removal of solid waste**
4 **from the Nation's lands; and**

5 **WHEREAS, the US Bureau of Land Management has allocated a \$50,000 grant to the Solid Waste**
6 **Management Program to clean-up solid waste left behind by undocumented**
7 **migrants.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
9 **the acceptance and expenditure of the US Bureau of Land Management grant, in the**
10 **amount of \$50,000, for the Solid Waste Management Program FY2007 Undocumented**
11 **Migrant Waste budget 11-1513, in accordance with the attached budget hereto.**

12 **BE IT FINALLY RESOLVED by the Tohono O'odham Nation Legislative Council that the Tohono**
13 **O'odham Nation's Officials, to wit: the Chairwoman, Vice Chairman and any**
14 **designated person are hereby authorized to negotiate and execute the grant,**
15 **provided however, that any amendments affecting the funding levels of the grant**
16 **shall be submitted for further prior approval by the Tohono O'odham Legislative**
17 **Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST day**
19 **of MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (d)(2)& (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
22 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**
