

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Authorization to expend FY2006 Indian Health Services Memorandum of Agreement  
carryover funds for Water Resources Study Program FY2007 budget 11-5016)**

**RESOLUTION NO. 06-167**

1 **WHEREAS, the Tohono O'odham Legislative Council approved a Memorandum of Agreement**  
2 **between the Water Resources Study Program and the Indian Health Service and**  
3 **budget 11-5016 through Resolution 01-313; and**

4 **WHEREAS, the Water Resources Study Program has accumulated carry forward funds in FY2006**  
5 **in the amount of \$12,073.86; and**

6 **WHEREAS, the Water Resources Study Program budget FY2007 11-5016 has been reviewed by the**  
7 **Legislative Water Resources Committee and the Legislative Budget and Finance**  
8 **Committee.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
10 **authorizes the expenditure of FY2006 carry forward funds in the amount of \$12,073.86**  
11 **for the Water Resources Study Program FY2007 budget 11-5016, in accordance with**  
12 **the budget attached hereto.**

13 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
14 **Nation's Officials, to wit: the Chairwoman, Vice-Chairman, and any designated**  
15 **official are authorized to negotiate and execute the agreement, provided however,**  
16 **that any amendments affecting the funds or funding levels of the agreement shall be**  
17 **submitted for further approval by the Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> day**  
19 **of MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
21 **Section 1 (d)(2)& (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**  
22 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
24 **18, 1934 (48 Stat. 984).**
