

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval to accept and expend the Environmental Protection Agency's Source
Water Assessment Program Grant for the Water Resources Study Program
FY2007 budget 11-5020)**

RESOLUTION NO. 06-168

1 **WHEREAS, the Water Resources Study Program was awarded an Environmental Protection**
2 **Agency's Source Water Assessment Program (SWAP) grant for the protection of the**
3 **Nation's Tohono O'odham Utility Authority public drinking water system, from natural**
4 **and man-made contamination, in the amount of \$80,000.00; and**


5 **WHEREAS, the Water Resources Study Program SWAP budget has been reviewed by the**
6 **Legislative Water Resources Committee and the Budget and Finance Committee.**

7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
8 **authorizes the acceptance and expenditure of the Environmental Protection Agency**
9 **SWAP grant, in the amount of \$80,000.00 for the Water Resources Study Program**
10 **FY2007 budget 11-5020, in accordance with the budget attached hereto.**

11 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
12 **Nation's Officials, to wit: the Chairwoman, Vice-Chairman, and any designated official**
13 **are authorized to negotiate and execute the grant, provided however, that any**
14 **amendments affecting the funds or funding levels of the grant shall be submitted for**
15 **further prior approval by the Tohono O'odham Legislative Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST day**
18 **of MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
19 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
20 **Section 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
21 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
23 **18, 1934 (48 Stat. 984).**




