11	Nation's Officials, to wit: the Chairwoman, Vice-Chairman, and any designated
12	official are authorized to negotiate and execute the grant, provided however, that any
13	amendments affecting the funds or funding levels of the grant shall be submitted for
14	further prior approval by the Tohono O'odham Legislative Council.

16	of MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-
17	AGAINST; <u>-0-</u> NOT VOTING; and <u>[03] ABSENT</u> , pursuant to the powers vested in the Council by
18	Section 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation,
19	adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
20	Assistant Secretary-Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
21	of June 18, 1934 (48 Stat. 984).
